Appropriate referrals Client contacts the Client intake with legal clinic (with or an intake worker without assistance) Intake transferred to a caseworker

# **Mobile Outreach Clinic**

- The Mobile Outreach Clinic is a free drop-in clinic for low-income people in North Halton. This service is jointly delivered by HCLS and the Legal Clinic of Guelph and Wellington County.
- A lawyer or paralegal, along with a rural community worker, are available between 10am to 3:30pm to speak with community members about their legal issues.
- We alternate between Acton & Georgetown every Friday.
   From October to May we are indoors at the Halton Hills Public Library Branches.

# Fee Waived Birth Certificate Replacement


- Working together with our community partners, we help people who are unhoused replace their Ontario Birth Certificates for free. Service providers can contact us to access this program for their clients


